Dear all,

Doctoneuro is organizing its 4th General Assembly (GA), which will be held on **Friday, November 29th at 6.30 pm** (Salle Paul Mendel of the Institute of Cellular and Integrative Neuroscience - 8, Allée du Général Rouvillois, 67000 Strasbourg). This meeting will be followed by a convivial evening, the location of which will be communicated to you later.

Thanks to you, the Association has been able to gather 114 members last year September. With a Bureau composed of 12 elected members and 10 supportive members (PhD students, master students, post-docs, alumni), we have been able, through our actions (which will be presented to you during the GA), to strengthen our network and make the values that unite us prosper (cf. Our statutes).

The General Assembly is an important step in the life of an association. It makes it possible to discuss the assessment of the mandate that is coming to an end, both moral and financial, to debate them, and to finally define the orientations of the next mandate, by electing new members of the Bureau.
