RULES AND REGULATIONS FOR THE DOCTONEURO WEEKEND OF 06-07/04/2024

Preamble:

Rules governing the Week-End Doctoneuro of April 06 and 07, 2024. The points detailed below are based on common sense rules of community life and the French legislation at the date of the weekend. The safety of participants as well as the image and reputation of the Doctoneuro association, and of the NCI-NCO-JMN-Neuro3P Master's of the University of Strasbourg, depend on the smooth running of the weekend.

PART 1. Participation and Registration

Article 1: Participation in the weekend

Even after payment of the registration fees, the organizing team reserves the right to refuse and refund a registration if it does not meet the requirements described below:

- Participants must be members of Doctoneuro at the time of registration.
- The purpose of the weekend is to strengthen the cohesion between the members studying neuroscience at the University of Strasbourg. Thus, all members must be students in neuroscience at the University of Strasbourg to register.
- Participants must return the signed rules and regulations of the weekend, and the image rights form to the organizing team at least 2 weeks before the date of the weekend.

Article 2: Refunds/Cancellation of registration

As described in article 1, the organizing team has the right to refuse a registration if it does not meet the prerequisites.

Participants may cancel their registration at any time. Refunds will only be given if the organizing team is notified at least 1 week before the start of the weekend.

PART 2. Course of the weekend

Article 3: Respect of the instructions given by the organizers

The participants commit themselves to respecting the instructions given by the organizing team of the weekend, from departure to return to the meeting point of the bus. They commit themselves to respecting the material at their disposal.

Article 4: Rules of good conduct

No violence will be tolerated (physical, verbal, moral, sexual, ...). Each participant agrees to respect the rules of community life.

In case of need, participants will be able to refer to clearly identifiable "safe people", designated by the organizing team.

Article 5: Means of transport

Only the members of the organizing team are allowed to go to the place of stay of the weekend by car. The participants will have to make the trip from Strasbourg to the place of the weekend by the bus provided by the organization.

Departure from Strasbourg on April 06, 2024: participants agree to be present at the meeting time set by the organization. If not, they will be considered as absent, which implies their non-participation in the weekend without reimbursement of the registration fee.

Article 6: Place of stay

No departure from the perimeter of the place of stay will be tolerated, apart from the hike led by the organizing team on Sunday afternoon.

It is forbidden to let anyone who is not on the list of weekend participants enter the premises.

Participants agree to respect the infrastructure and equipment provided.

Article 7: Consumption of alcohol

Access to alcohol during the weekend is strictly controlled by the organizing team. It is forbidden to participate in the weekend with your personal stock of alcohol. The organizing team has the right to confiscate/empty containers holding drinks not provided by the organization.

Beyond the measures put in place by the organizing team, participants commit to moderate their alcohol consumption. Any member of the organizing team may limit or suspend the delivery of alcohol to one or more members, if they deem it necessary.

Article 8: Tobacco

Smoking or vaping is not permitted in any enclosed space, including dormitories.

Article 9: Illegal substances and prohibited objects

As described by the law, the use of illegal substances or possession of weapons is strictly prohibited. If necessary, the authorities will be contacted.

The consent of the participants to the rules described above is a condition *sine qua non* for their registration and participation in the weekend.

In the event of a breach of the rules or inappropriate behavior, the organizing team reserves the right to exclude a participant. The participant will then have to leave the weekend.
